



Return to Play Guidelines provided below have been developed in observance of the Governor’s Forward Virginia Blueprint, Prince William County’s Office of Executive Management guidance and the Department of Parks, Recreation & Tourism (DPRT) programming standards. These guidelines are subject to change in accordance with any federal, state, and local health requirements.

<b>Activity Level</b>	Scope of activity permitted during each phase. Competition at DPRT sites only.
<b>Participation</b>	Total number of individuals authorized to gather on a field.
<b>Permits</b>	Field permits to be issued by Sports Services in accordance with the above guidelines and PWC policies.
<b>Field Division</b>	Groups are permitted to sub-divide fields into halves under Phase 1 guidelines. Division of fields under Phases 2 & 3 is conditional upon meeting the appropriate social distancing requirements among the number of participants on-site.
<b>Social Distancing</b>	Recreational sports may occur if six feet of physical distance can be maintained by all instructors, participants and spectators.
<b>Physical Contact</b>	Competition that involves close contact with other athletes must be avoided. Incidental contact or contact between members of the same household is acceptable. Phase three contact is conditional pending additional guidance.
<b>Spectators</b>	Spectators should remain off the field of play and practicing social distancing guidelines.
<b>Concessions</b>	Concessions are limited to prepackaged items only in phases two and three.
<b>Restrooms</b>	Fixed restroom access is expected to be available in phase two, where applicable. Portable restrooms are expected to be available and returned to normal cleaning schedules in Phase One.
<b>League Buildings</b>	League buildings are again accessible. Leagues must look to implement the appropriate cleaning and disinfection procedures before and after use. It's recommended leagues limit access to these buildings.
<b>Tournaments</b>	Baseball and Softball Tournament play may resume during phase three provided the tournament organizers submit a detailed operations plan indicating what safeguards are being put in-place in observance of these guidelines.
<b>Special Events</b>	Special Event approval is conditional in phase three only pending review and approval by PWC Assistant Director of Recreation and Chief Park Ranger.
<b>Grounds Services</b>	Requests for additional field services are contingent on available staffing and resources.
<b>Amenities</b>	All amenities must be cleaned and disinfected before and after use by the permitted groups. Bleachers are not available.
<b>Equipment</b>	There is no sharing of equipment in phase one. Equipment sharing is conditional in phases two and three as all shared items must be disinfected between each use to the extent practicable.
<b>Signage</b>	Groups will be required to post information on their website providing public health reminders about social distancing, gatherings, options for high risk individuals and staying home if sick. DPRT will review signage options at park facilities.
<b>PPE Masks</b>	Masks/face coverings are required when social distancing cannot be maintained or when in areas where people tend to congregate. Masks are to be worn so that they cover both the mouth and nose. Mask requirements apply to participants when not engaged in sports activities and spectators. Masks are recommended for those ages 2+ when possible.
<b>COVID-19 Acknowledgment</b>	Groups must alert all participants and/or guardians of the inherent risks of sports participation as it relates specifically to COVID-19 via a written form of acknowledgment.
<b>COVID-19 Response Plan</b>	Groups must have a response plan in-place to anyone experiencing symptoms and/or has been exposed to COVID-19 to include, but not limited to, transportation to their home or health care facility.
<b>COVID-19 Screening</b>	Groups must conduct daily screenings of coaches, officials, staff and players of COVID-19 symptoms prior to admission. Screening should be conducted in accordance with applicable privacy and confidentiality laws. Screening may be completed by parents and/or via verbal confirmation with adults upon arrival. It's highly recommended that screening occur periodically by coaches throughout the course of the activity/event in all three phases.
<b>Compliance Marshal</b>	During all games and tournament activities the permit holder shall designate one individual to ensure compliance with return to play guidelines including mask and social distance guidance.
